Preliminary reports are issued to the county medical examiner investigator within several days following the completion of the postmortem examination, and contain the information needed to complete the death certificate. Completion of the final autopsy report is not necessary in order to certify a death and file a death certificate. For example, a death certificate containing a “pending” cause and/or manner of death is a valid certification of death, and may be amended at a later date
